



**LAUNCHING OF THE REGIONAL ANTI-BULLYING POLICY**

1. As part of the Department of Education's commitment to uphold the safety, well-being, and holistic development of all learners, the DepEd - National Capital Region has formulated the Regional Anti-Bullying Policy that aims to create and sustain a safe, inclusive, and learner-centered school environment across all public schools in the Region.

2. Anchored on existing child protection policies and aligned with DepEd's mandate on learner welfare, the policy provides a clear and actionable framework of evidence-based strategies, defined roles and responsibilities, implementation timelines, and monitoring mechanisms to ensure consistent, effective, and sustainable prevention and response to bullying in all its forms.

3. In line with this, **DepEd - NCR will hold the Launching of the Regional Anti-Bullying Policy on January 7, 2026 at 9:00 AM, to be held at the Meeting, Incentives, Conferences, and Exhibitions (M.I.C.E.) Center, Quezon City.** The event aims to formally present the policy, orient concerned education stakeholders on its salient provisions, and ensure its effective and uniform implementation in all schools and offices within the Region.


