

1. In reference to DepEd Order No. 47, s. 2016 titled *Omnibus Policy on Kindergarten Education*, it is important to determine achievement of competencies across developmental domains as articulated in the Revised Kindergarten Curriculum Guide.
2. This summative form of assessment is conducted through the administration of the Philippine ECD Checklist, and teacher-made assessment tools like portfolio assessment and performance-based tasks.

4. Likewise, the monitoring of the administration of the Philippine Early Childhood Development (ECD) Checklist posttest is also scheduled from February 10, 2026 to March 13, 2026. It is highly encouraged that the **'No Disruption of Classes Policy'** be observed during this assessment period.
