

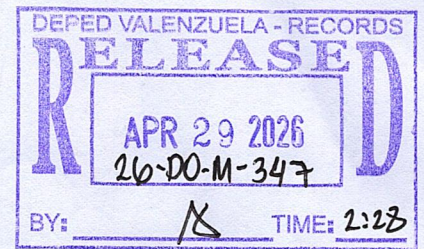

1. This Office hereby announces the official release of the Philippine Educational Placement Test (PEPT) results for examinees who took the test on February 15, 2026, at Valenzuela National High School, Marulas, Valenzuela City.
2. The release of PEPT results shall commence on April 22, 2026, and will be conducted from Monday to Thursday, between 9:00 a.m. and 4:00 p.m., at the School Management Monitoring and Evaluation (SMME) Section, Schools Division Office of Valenzuela City.
3. The PEPT results shall be released exclusively to the School Head or an authorized representative of the school where the learner is officially enrolled.
4. Authorized representatives are required to present the following documents upon claiming the results:
 - a. A letter of authorization duly signed by the School Head; and
 - b. A valid identification card (ID).
5. School Heads are enjoined to ensure the proper, timely, and confidential dissemination of results to concerned learners, in accordance with existing Department of Education policies on data privacy and assessment protocols.

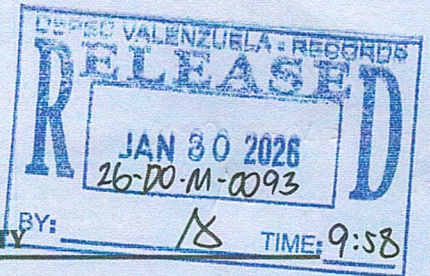
