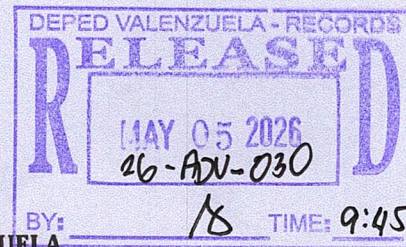

**SUBJECT : AUTOMATIC PAYROLL DEDUCTION SYSTEM (APDS) CODE FOR
THE GSIS GINHAWA LITE AND GINHAWA FLEX**

This is to inform all concerned offices and personnel of the prescribed deduction codes to be used in the payroll processing and reporting of deductions under the Government Service Insurance System (GSIS) Ginhawa Loan Programs, which were previously referred to as Multi-Purpose Loan products.

Please be guided of the following deduction codes:

Deduction Code	New Loan Product	Previous Loan Product
1252	Ginhawa Flex	MPL Flex
0133	Ginhawa Lite	MPL Lite

All Regional Offices (ROs), Schools Division Offices (SDOs), and other concerned units are directed to use these prescribed deduction codes in the processing, recording, and reporting payroll deductions under the said loan programs.

The Solutions Development Division, Information and Communications Technology Service (ICTS), is hereby enjoined to immediately provide the necessary system support, including the updating of loan product names in the payroll system, and to render technical assistance to all concerned offices, as the need arises.

All existing verification procedures prior to the implementation of payroll deductions shall continue to be strictly observed.
