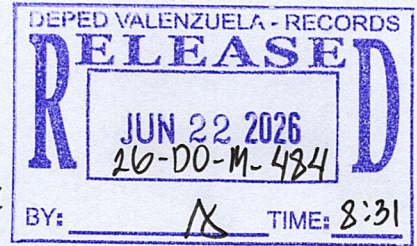

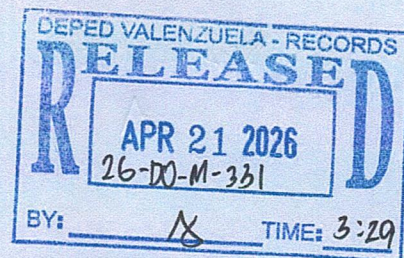

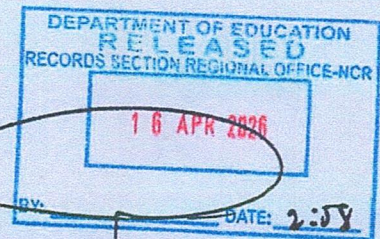

REGISTRATION FOR THE SCHOOL SPORTS SUPPLIES MATERIALS AND EQUIPMENT ENHANCEMENT DISTRIBUTION PROGRAM (SSEEDP)

1. In line with the continuous implementation of the School Sports Supplies and Equipment Enhancement Distribution Program (SSEEDP), all Schools Divisions in the National Capital Region (NCR), through their respective Division Sports Officers, are hereby requested to ensure the registration of all schools within their respective divisions.
2. All schools are required to accomplish and upload the necessary documents, specifically Form SSC. 1 and Form SSC. 2, through the following link: <https://tinyurl.com/SSEEDP-REGISTRATION-LINK> on or before **June 30, 2026**.
3. The consolidated registration of schools shall serve as the official basis for identifying recipient schools of the SSEED Program. Only those schools that have successfully registered shall be considered eligible for the downloading of funds from the Central Office.
4. Division Sports Officers are advised to monitor and ensure 100% compliance of schools within their jurisdiction.
