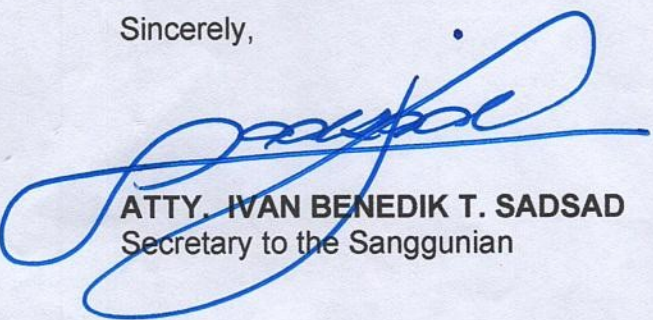

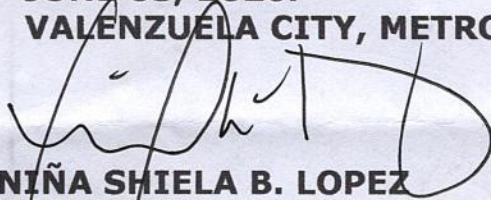
maintain their honesty stores as a means of promoting discipline, honesty, accountability, and responsibility among students.
