







This Memorandum is issued for information and guidance relative to the invitation from the Office of Hon. Antonio L. Tinio, Representative, ACT Teachers Partylist, for the conduct of a Teachers' Consultation on Thursday, 19 February 2026, at around 2:00 PM, at the House of Representatives, Quezon City, subject to venue confirmation.

In this connection, Schools Division Offices may allow the participation of Faculty Club Presidents from public schools, subject to the following conditions:

1. Participation shall be prorated per Schools Division Office, as follows:
 - * Big SDOs-ten (10) Faculty Club Presidents
 - * Medium/Small SDOs-seven (7) Faculty Club Presidents
2. Participation shall be strictly subject to the non-disruption of classes, consistent with existing DepEd policies, including the primacy of uninterrupted teaching and learning time. Schools and SDOs shall ensure that appropriate arrangements are in place so that classroom instruction and other essential school operations are not affected.

The activity is intended to provide a venue for dialogue on legislative initiatives and policy concerns affecting teachers, including matters on salary, benefits, education budget, and governance issues.
